#### 一、源起 History

近年來,台灣經濟快速發展,為國民創造了許多的財富,但是身心障礙、慢性 病、老人疾患、意外傷害、憂鬱自殺與藥酒濫用等議題卻日趨嚴重;老人、身心障礙 者與慢性病患的照護成為目前重要的健康問題,甚而為社會問題。由於預防重於治 療,全球性醫療照護的趨勢由醫療模式邁向疾病預防與健康促進,因此,有關健康照 護專業人才之需求迫切需要。

本所為整合相關健康照護專業,應用成大醫學院的行為醫學、心理、職能治療、 物理治療、老年等五系所碩士班及其他各學科的人才與物力資源,以培養涵蓋生理、 心理及社會的全人照護之高級研發與領導專業人才,並發展身-心-社會層面兼顧之健康 照護研究與政策。本所於民國 91 年奉准成立,並於民國 92 年 8 月開始招生。

In recent years, Taiwan's economy has developed rapidly, creating substantial wealth for its citizens. However, issues such as disabilities, chronic diseases, elderly ailments, accidental injuries, depression, suicide, and substance abuse have become increasingly serious. The care of the elderly, people with disabilities, and chronic disease patients has emerged as a significant health problem and even a social issue. Since prevention is more critical than treatment, the global trend in healthcare is shifting from a medical model to disease prevention and health promotion. Therefore, there is an urgent need for professional talent in health care.

This institute aims to integrate related healthcare professions, utilizing the resources of the College of Medicine at National Cheng Kung University, including the graduate programs in Clinical Psychology, Psychology, Occupational Therapy, Physical Therapy, and Gerontology, along with resources from various other disciplines. The goal is to train advanced research and leadership professionals in holistic care that encompasses physical, psychological, and social aspects. Additionally, the institute focuses on developing healthcare research and policies that address the physical, mental, and social dimensions. The institute was approved for establishment in 2002 and began enrolling students in August 2003.

#### 三、宗旨 Mission Statement of the Institute

本博士班旨在培育健康照護專業領域之領導者,發展跨領域全人照護之新知,推 動健康照護專業之成長,以提昇人類之身心健康及生活品質。

- Cultivate leaders in healthcare professionals.
- Develop advanced, multi-disciplinary knowledge for holistic healthcare.
- Promote the development of healthcare professionals.
- Elevate the physical and mental health of human beings as well as the quality of life.

## 四、發展重點與特色 Specific Healthcare Focus of the Institute

## (一) 婦女健康 Women Healthcare

從遺傳、生理、心理、社會及文化等因素探討婦女各生命週期之健康議題,例如 經前症候群、經痛、孕期壓力、周產期憂鬱、老化、更年期身心障礙等之多元成因與 介入方案。其中婦女心理健康領域重在探討為人母、女性之心理健康、與罹病特殊心 理歷程與經驗等相關議題,如:乳癌、憂鬱或受暴等,涵蓋質性與量性研究。本研究 群以推動婦女身心健康之促進與照護措施,並培養具有此方面研發與健康照護能力之 高階專業人才為宗旨。

Women's health issues across their life cycle, considering genetic, physiological, psychological, social, and cultural factors will be investigated. Topics include the multifaceted causes and intervention strategies for conditions such as premenstrual syndrome, dysmenorrhea, pregnancy stress, perinatal depression, aging, and menopausal disorders. The focus on women's psychological health involves exploring motherhood, women's mental health, and the unique psychological experiences and processes associated with illnesses such as breast cancer, depression, or exposure to violence, encompassing both qualitative and quantitative research. This faculty aims to promote and implement measures for enhancing women's physical and mental health and to train advanced professionals with expertise in research and health care in this domain.

(二)高齡健康與照護 Geriatric Care

以跨領域整合策略,致力於高齡者健康促進,以及疾病預防與照護之研究與人才 培育,並配合社會結構與文化特色,發展整合性高齡健康促進與照護模式,期成為亞 太地區首屈一指的實務與學術發展中心。

Based on the knowledge that chronic disease development is significantly related to lifestyle, this institute emphasizes the following topics: i) the acquisition and transformation of various health-related behaviors in geriatric subjects and their relevant factors, and ii) the development of effective healthcare strategies and programs for geriatric patients. Our ultimate goal is to become the top research center in the Asia-Pacific region.

(三)身心發展與照護 Healthcare for Mental or Physical Development

建立跨學科的發展照護模式,包括從理論、評估及介入等角度,探討身心發展與 健康照護、神經心智發展、動作發展、社會情緒發展,以及家庭環境與文化等因素對 身心發展與健康照護之影響,培養具有身心發展領域研發、教育與實務能力之高階人 才。

Establish an interdisciplinary developmental care model that explores the impacts of physical and mental development, neurocognitive development, motor development, socialemotional development, family environment, and cultural factors on physical and mental development. This model aims to cultivate top-tier professionals with expertise in research, education, and practical skills within the domain of physical and mental development.

(四)動作科學與照護 Applied Movement Sciences for Cognitive-Motor Disabilities and Sports /Occupational Injuries

依結合動作科學與認知的了解,就臨床患者的認知與動作功能做進一步的研究, 並依此發展治療性策略;研究中樞神經損傷患者的動作與認知表現的關係;並探究職 業與運動傷害之多元成因及其診斷、治療與預防方面之基礎與臨床研究。以增進動 作、認知障礙者之醫療與健康照護,並培養具動作科學領域研發與健康照護能力之高 階專才。

Based on the understanding of applied movement science, conducted on the cognitive and motor functions of clinical patients developed therapeutic strategies. This includes studying the relationship between motor and cognitive performance in patients with central nervous system injuries and exploring the multiple causes of occupational and sports injuries, as well as their diagnosis, treatment, and prevention through both basic and clinical research. The aim is to enhance medical and healthcare for individuals with motor and cognitive impairments while cultivating high-level professionals with expertise in motor science research and healthcare.

This research group applies movement sciences to investigate various aspects of interaction and integration of motor and cognitive functions in normal subjects and patients with cognitive/motor dysfunction and the pathomechanics, diagnosis, and intervention of sports/occupational injuries. Our research efforts are directed towards i) the acquisition of advanced knowledge of cognitive-motor function and the development of therapeutic strategies in patients with cognitive motor disabilities; ii) the study of the association between cognitive and motor performances in patients with central nervous system (CNS) injuries; and iii) the investigation of etiologies, diagnoses, treatments, and prevention measures for sports/occupational injuries via basic and clinical research. Our ultimate goal is to foster students to be top researchers and leaders in the healthcare profession.

(五) 心理健康 Mental Healthcare

從個體之主體性出發,來探究個體得以開發、持續以及增進完整心智特質與功能 之機制,從而應用心理健康三級預防之觀念來增益社會大眾之幸福感。學術層面上, 以反思創造模式來整合國際趨勢與本土性文化生態,探討多元健康照護領域於心理健 康三級預防之各重要議題、研究成果以及實務應用;教育層面上,則以培養跨生理照 護與心理健康領域之學術與臨床之領導人才為目標。

Studying the issues of multi-disciplinary healthcare and disease prevention (primary, secondary & tertiary prevention), based on both international and domestic trends, so these research findings can be applied in the clinical setting to improve the well-being of people. The students are trained to be high-level researchers and healthcare professionals in this area.

## 五、課程規劃 Course Planning

為因應跨領域學科整合的時代來臨,及台灣現階段臨床心理、職能治療、物理治療、老年等領域高階師資與學術研究人才的不足,訂定本所之教育目標,除著重培育臨床心理、職能治療、物理治療、老年等各專科領域的臨床照護、教學與新知研發專家外,更需具備國際觀與跨領域學術研究合作之能力。為達此目標,課程規劃以四大能力的培育為主軸:(1)跨領域全人照護能力;(2)研究能力;(3)專業領導能力;(4)溝通能力。

Due to the incoming time of multi-disciplinary healthcare and lack of professionals, especially in the following four fields, clinical psychology, physical therapy, and occupational therapy, this institute was then set up. We do not only aim to train clinical care professionals, but also cultivate academic experts in several aspects.

Four training values are as follows:

- 1) To develop holistic care capacity in the clinical field
- 2) To improve research and academic ability
- 3) To broaden global vision in both clinical and academic
- 4) To enhance communication ability

- 1. 專題討論課程由不同專業之博士生主持、口頭報告、評論與討論。
- 「臨床研究設計」課程之期末報告為由不同領域博士生共同合作,撰寫一跨 領域研究計畫。
- 規定博士論文本身就必須為一<u>跨領域之研究</u>。

To prepare students with multi-disciplinary healthcare knowledge and skills, students will complete the program by attending courses and conducting research at the Institute of Allied Health Science, please read the following:

(1) The "Seminars" are designed to be a student-centered learning process by providing an opportunity for the students to engage in in-depth discussion of his/her research interests with his/her mentors and commentators.

(2) In "Clinical Research Design", students from different research groups will be expected to write a multi-disciplinary research proposal.

(3) The doctoral dissertation is required to be a multi-disciplinary research study. The advisor for the thesis shall be an expert in multi-disciplinary research. The faculty suggests students have one co-advisor, who is from the multi-disciplinary research.

#### 第一章 總 則

#### **Chapter 1 General Principles**

- 第一條 本校為配合國家建設,提高學術研究,特遵照「大學法及其施行細則」設立學 系(所)碩士班及博士班,培養高級專門人才,並依據部頒「學位授予法」、本校 「碩、博士班研究生招生規定」及本校學則第三十條之規定訂定本章程。
- Article 1 NCKU Graduate Program Regulations (the Regulations, hereafter) are established by National Cheng Kung University (NCKU) to promote its academic research in line with national development in accordance with the University Act, Enforcement Rules of the University Act (大學法及其施行細則), Degree Conferral Act (學位授予法), NCKU Regulations of Master's and Doctoral Student Recruitment (本校碩博士班研 究生招生規定), and Article 30 of National Cheng Kung University Academic Regulations (國立成功大學學則).
- 第二條 本校碩士班及博士班研究生入學、註冊、選課、修業期限、學分、成績、轉 所、退學、畢業及授予學位等悉依照本章程辦理。
- Article 2 Academic matters of NCKU graduate programs with regards to admission, registration, course enrollment, study duration, course credits, academic performance evaluation, program transfer, withdrawal/dismissal, graduation, and degree conferral shall be administered according to the Regulations.

## 第二章 入學

#### **Chapter Two: Admission**

- 第三條 凡國內公立或已立案之私立大學,或經教育部認可之外國大學畢業,得有學士 學位,或合於同等學力規定者,經本校碩士班研究生入學考試錄取者,或以公 開方式辦理對校內外大學部畢業生及應屆畢業學生甄試錄取之學生,得入本校 碩士班肄業。
- Article 3 Candidates who are graduates with a bachelor degree from a government-run or government-registered college/university in Taiwan ROC, or from an MOEaccredited college/university abroad, or those who are qualified with an equivalent educational level according to the relevant education regulations will be granted admission into the master's program of their choice at NCKU after they pass the regular master's program entrance examinations or get accepted through an open recommendation-based screening examination designated for undergraduate program graduates or graduating students registered at NCKU or another approved university.
- 第四條 凡國內公立或已立案之私立大學,或經教育部認可之外國大學研究所畢業得有 碩士學位,或合於同等學力規定者,經本校博士班研究生入學考試錄取者,得 入本校博士班肄業。本校應屆畢業學士班學生、碩士班研究生,合於逕行修讀 博士學位資格者,得申請逕行修讀博士學位。其申請辦法另訂之。
- Article 4 Candidates who are graduates with a master's degree from a government-run or government-registered college/university in Taiwan, ROC, or from an MOEaccredited college/university abroad; or those who are qualified with an equivalent educational level according to the relevant education regulations will be granted admission into the doctoral program of their choice at NCKU after they pass the regular doctoral program entrance examinations. NCKU undergraduate program graduating students or master's program students who meet the qualifications for direct admission into doctoral programs may apply for admission to a doctoral program. Application regulations shall be formulated in a separate text (NCKU Operating Rules for Direct Admission to PhD Programs).
- 第五條 申請入學之外國研究生,符合第三條或第四條資格規定經本校審查或甄試合格 者,得入本校碩士班或博士班就學。
- Article 5 International candidates who fulfill the requirements prescribed in Articles 3 or 4 are eligible to apply for admission into NCKU graduate programs. Applications shall be approved through a screening examination or review process for admission into a master's or doctoral program of their choice.
- 第六條 本校招收碩士班及博士班研究生,均應訂定招生簡章並成立招生委員會,由校長任主任委員,各學系(所)亦應組成招生小組秉公正、公平、公開原則,依本校碩、博士班研究生招生辦法辦理招生事項。本校招生辦法由教務會議另訂之,並報教育部核定。

Article 6 NCKU shall publish an admission brochure and form an admission committee, chaired by the University President, for the recruitment of students into graduate programs. Every department/institute shall form its admission committee to administer student recruitment in a fair, impartial and open manner according to NCKU Regulations for Graduate Program Admissions. NCKU admission regulations shall be established in a separate text by the Academic Affairs Council and submitted to the Ministry of Education for ratification.

#### 第三章 註冊、選課

#### **Chapter 3 Registration and Course Enrollment**

- 第七條 研究生入學註冊後,依各該學系(所)規定之科目表及本校學生選課辦法辦理選課,其應修課程及研究論文須經指導教授及學系(所)主任 (所長)核准。指導教授須為本校教師,其資格及選任應依系(所)規定並經學系 (所)主任(所長)同意。本校教師與研究生具有配偶、三親等內之血親或姻親,或曾有上述關係者,不得擔任其指導教授。
- Article 7 Upon registration, graduate students shall complete their course enrollment each semester according to the program-designated curriculum requirements and NCKU Course Enrollment Regulations. Their course enrollment and thesis/dissertation shall be approved by their academic advisors and the institute director. Academic advisors shall be assigned from NCKU faculty members. The qualifications and appointments of academic advisors shall be regulated by the graduate institute and approved by the director. A faculty member who was or is related to a graduate student as a spouse, or by blood or marriage within the third degree shall not serve as an academic advisor of the student.

#### 第四章 修业期限、学分、成绩、转所、辅系、雙主修

#### Chapter 4 Study Duration, Course Credits, Academic Evaluation, Transfer, Minors, and

#### **Double Majors**

第九條 碩士班研究生修業期限以一至四年為限。
 碩士在職專班之修業年限以一年至四年為限,但未在規定之修業期限內修滿應
 修課程或未完成學位論文者,修業期限得再延長一年為限。
 博士班研究生修業期限以二至七年為限。
 逕攻博士學位者修業期限至少三年,至多七年為限。
 碩博士班在職生未在規定修業期限修滿應修課程或未完成學位論文者,修業期
 限得再延長一年為限。

修讀雙主修學生延長修業期限,依其修讀辦法之規定辦理。

前項「在職生」身分之界定,以入學時之報考身分為準。

領有身心障礙手冊學生或各直轄市、縣(市)政府特殊教育學生鑑定及就學輔導 委員會鑑定為身心障礙安置就學者,因身心狀況及學習需要,得延長其修業期 限,最長以四學年為限。

學生因懷孕、生產或哺育三歲以下子女之需要,其延長修業期限依相關證明文 件核定年限。

Article 9 Article 9 Master's program students shall complete their program degree within the regular study duration of four years (a minimum of one year and a maximum of four years). Students in specialized master's programs for in-service students shall complete their program degree within the regular study duration of four years (a minimum of one year and a maximum of four years). Should they fail to complete their coursework requirements or degree theses within the designated duration, they shall be allowed to extend their study for a maximum of one year. Doctoral students shall complete their program degree within the regular study duration of seven years (a minimum of one year and a maximum of seven years). Students directly admitted to doctoral programs shall complete their program degree within the regular study duration of seven years (a minimum of three years and a maximum of seven years). In-service students on master's and doctoral programs shall complete their program degree within the regular study duration. Should they fail to complete their coursework requirements or degree theses/dissertations within the designated duration, they shall be allowed to extend their study for a maximum of one year. The term of "in-service student" in the preceding rule is defined as the status of the candidate registered for NCKU entrance examinations. Students who are enrolled for a double major shall be allowed a maximum study extension according to related regulations. Students with disability identification, or those who are certified with a disability status and thus eligible for a higher education placement program by a special education committee under the authority of the local government, are allowed study extensions to a maximum of 4 academic years due to special needs. Those who need to defer their graduation for pregnancy, birth delivery, or care for children under three shall be allowed a designated maximum study extension according to the related certificates.

Article 9.1 Graduate students shall pursue a minor or double major in accordance with NCKU Minor Program Regulations and NCKU Double Major Program Regulations.

- Article 10 Master's program students are required to complete a minimum of 24 credits. Doctoral students are required to complete a minimum of 18 credits. Students directly admitted to doctoral programs are required to complete a minimum of 30 credits. The required minimum number of credits stated above excludes the six credits designated for a master's degree thesis or the 12 credits designated for a doctoral degree dissertation.

  - (一) 以科目之學分數乘該科目成績為學分積。
  - (二) 以學分總數除總學分積為學期平均成績。
  - (三) 學期學業平均成績之計算包括不及格科目成績在內。
  - 二、畢業成績:以學業平均成績與學位考試成績之平均,為其畢業成績。
- Article 11 Graduate students are evaluated on a grading scale of 0 to 100 points (equivalent to the calculating system adopted for undergraduate programs) for academic performance and degree examinations, with 100 as the highest grade and 70 as the lowest passing grade. Students failing to receive a grade of 70 or above for a course will not be given course credits. Those who fail to pass a required course are allowed no remedial exams and shall repeat and complete the course before graduation. The passing grade for moral conduct is 60. The passing grade for courses in the Education Program is 60. Those who fail to pass a course are allowed no remedial exams. Course grades and credits received from the Education Program are not calculated into grade point average or the number of credits for the semester. The passing grade for undergraduate courses taken by graduate students is 60. Those who fail to pass an undergraduate course are allowed no remedial exams. Course grades and credits received from undergraduate programs are not calculated into grade point average or the number of credits for the semester. However, this rule is subject to change under special circumstances proposed in a report by the program and approved by the Vice President for Academic Affairs. Academic grades for each semester and graduation are calculated as follows:

1. Semester grade average: 1.1 The grade of each course taken in the semester is multiplied by the course credit number into an integrated value for the course. All

integrated values are added up into the total grade for all courses taken in the semester. 1.2 The semester grade point average is calculated based on the division of the total grade by the total credit hours of the courses taken in the semester. 1.3 Calculation of the semester grade point average does not include failing grades. 2. Graduation grade: Graduation grade is calculated by averaging the sum of the cumulative grade point average and the grade for the degree examination.

- 第十二條 研究生修業滿一學年以上,或境外研究生修業滿一學期以上,因特殊情形,經 原肄業學系(所)與擬轉入之學系(所)雙方主任(所長)認可,並經教務長核准 者,得申請轉所(組),並以一次為限,一經核准即不得再返原學系所組。研究 生轉所相關規定,由各系所自訂,並明列於研究生修業規定。
- Article 12 Domestic graduate students who have completed their first year of study in their program, or graduate students from overseas who have completed their first semester of study in their program may apply for transfer to a new program under special circumstances, which shall be approved by both program directors and the Vice President for Academic Affairs. Program transfers shall be subject to a maximum of one application. Upon approval, students are not allowed to transfer back to the original program. Program transfers shall be regulated by graduate institutes and specified in their program academic regulations.
- 第十二條 研究生在學期間所著論文、作品、成就證明、書面報告、技術報告或專業實務 之一 報告有造假、變造、抄襲、由他人代寫或其他舞弊情事或違反學術倫理者,所 屬學系(所、學位學程)應組成專案小組進行調查,調查屬實後作成懲處之建 議,經學系(所)、院相關會議同意,送本校學生獎懲委員會審議。
- Article 12.1 Should a thesis or dissertation, work(s), proof of achievement, written report, technical report, or professional practice report, produced by a graduate student, contain fabricated, altered, plagiarized material, or ghost authorship, or constitute some other form of fraud in defiance of academic ethics, a special committee shall be formed by the related department (institute or degree program) to conduct an investigation. The committee shall recommend penalties for a confirmed case, which shall be approved by the related department (institute, degree program, and college) and submitted to the Student Rewards and Disciplinary Committee for review.

#### 第五章 退學

#### **Chapter 5: Dismissal**

第十三條 研究生有下列情形之一,應令退學:一、修業期限屆滿,仍未通過學位考試 者。二、博士班研究生資格考核未依該學系(所)規定年限及次數完成者。三、 學位考試不及格,經重考一次仍不及格者。四、逾期未註冊或休學逾期未復學 者。五、操行成績不及格者。六、原入學資格經審核不合格者。七、依本校學 生獎懲要點規定應予退學者。八、其他符合各學系(所)修業規章中之退學規 定,經學系(所)務會議、院相關會議同意送學生獎懲委員會決議並經校長核 定退學者。

Article 13

Students shall be dismissed from NCKU under one of the following circumstances: 1. Students who fail to pass degree examinations within the designated study duration. 2. Doctoral students who fail to complete the qualifying examinations within the program-designated period as a result of the maximum number of allowed attempts. 3. Students who fail to pass the degree examinations twice. 4. Students who fail to register or re-enroll after a study suspension by the designated deadline. 5. Students who receive a failing grade for personal conduct.6. Students who are disqualified by NCKU for admission. 7. Students who should be dismissed from NCKU according to NCKU Directions for Student Rewards and Penalties. 8. Students who reach the standards of dismissal according to their affiliated program regulations, upon approval by the institute council and the related college council, shall be reported to the Student Rewards and Penalties Committee for a resolution of dismissal from NCKU, which shall be approved by the President.

#### **Chapter 6 Graduation and Degree Conferral**

- Article 14 Graduate students who fulfill the following requirements are qualified for graduation: 1. Students who have completed the required course credits within the designated years of study. 2. Students who have passed the degree examinations in accordance with NCKU Enforcement Rules for Doctoral and Master's Degree Examinations. NCKU Enforcement Rules for Doctoral and Master's Degree Examinations shall be established separately and submitted to the Ministry of Education for ratification.
- 第十五條 合於前條規定之碩、博士班研究生,由本校碩、博士學位考試委員會考試通過 後,由本校授予碩、博士學位並發給學位證書。
- Article 15 Students who are qualified for graduation under Article 14, upon completion of the master's/doctoral degree examinations administered by related NCKU committees, shall be conferred a master's/doctoral degree with a diploma.
- 第十五條 已授予之學位,其論文、創作、展演、書面報告或技術報告如有抄襲、舞弊情 事或違反學術倫理情節嚴重者,經調查屬實者,撤銷其學位。 之一
- Article 15.1 A degree shall be revoked if a thesis, dissertation, creative writing, performance,

written report or technical report, produced by the recipient, is found to have involved plagiarism, fraud, or violations of academic integrity.

    Clinical psychology: The accelerated PhD student is required to complete an additional 9 credits in psychopathology, 6 credits in psychological assessment, 6 credits in psychotherapy, and 16 credits in Clinical Internship Program (I) and (II), totaling 37 credits. However, students with a Clinical Psychologist Certificate from the Ministry of Health and Welfare. Taiwan is exempt from the 16 Clinical Psychology Practicum (I) and (II) credits, reducing the total requirement to 21 credits.

Physical therapy: The accelerated PhD student is required to complete the credits required by the master's program of the Department of Physical Therapy.

   Occupational Therapy: The accelerated PhD student is required to complete 24 credits from the master's program of the Department of Occupational Therapy.
- 2. 本所發展重點與特色為以下五項研究群:(1)婦女健康、(2)高齡健康與照護、(3)身 心發展與照護、(4)動作科學與照護、(5)心理健康,此五項研究群亦為本所跨領域 之研究方向。本所入學考試採專業分組--臨床心理(甲)組、臨床認知神經(乙)組、物 理治療(丙)組、職能治療(丁)組及高齡照護(戊)組方式進行審查,為落實跨領域研 究,學生入學後,需自選考專業分組內之教師中選定指導教授,並於五項跨領域研 究中選定至少一項研究群參加,且指導教授須有參與該項跨領域研究群,此外,學 生需依其選定之該項跨領域研究群相關規定,修習相關課程。 The main focus areas and distinctive features of our institute are encapsulated in the following five research groups: (1) Women's Health, (2) Geriatric Care, (3) Healthcare for Mental or Physical Development, (4) Applied Movement Sciences for Cognitive-Motor Disabilities and Sports /Occupational Injuries and (5) Mental Healthcare These five programs provide the framework for how the program's interdisciplinary research courses are organized. Within any of the courses offered by the program, the students will be grouped based on their specialty: Clinical Psychology A, Clinical Cognitive Neuroscience (psychology) B, Physical Therapy C, Occupational Therapy D, and Geriatric Care E to allow the assessment material to be evaluated separately. Students need to participate in at least one of the five interdisciplinary research groups and choose their advisor related to

the professional group. The advisor chosen must be active and participate in interdisciplinary research. Students are required to fulfill the course requirements of the chosen interdisciplinary research course.

- 第一條 國立成功大學(以下簡稱本校)為辦理各系(所、學位學程)學生抵免學分,訂 定本辦法。
- Article 1 These Regulations are established by National Cheng Kung University (NCKU) to administer applications for course credit waivers at each department (institute or degree program).
- 第二條 下列學生得申請抵免學分:
  - 一、轉系(所、學位學程、組)生。
  - 二、轉學生。
  - 三、重考生。
  - 四、先修讀學分後考取修讀學位者。
  - 五、持入學前於專科學校修習及格之科目證明者。五專畢業生其一至三年級視同高中、高職階段,其課程不得抵免。高中、高職階段,其課程不得抵免。
  - 六、預先修習碩、博士班課程成績達七十分以上,且學分未列入畢業最低學分 數內,而持有證明者。內,而持有證明者。
  - 七、學生在學期間經所屬學系((所、學位學程所、學位學程))核准於暑期修習本 校開設之學分班。核准於暑期修習本校開設之學分班。
  - 八、經本校核准出國進修或推薦送至境外大學短期修課修或推薦送至境外大學 短期修課者者。。
  - 九、持香港副學士或高級文憑資格入學本校學士班者。
  - 十、於教育部認可之國外大學院校修習課程取得之學分,且經本校各系於教育 部認可之國外大學院校修習課程取得之學分,且經本校各系((所、學位 所、學位學程學程))核准者。
  - 前項第一、二及三款學生再經核准轉系學位學程、組、修讀輔系 學位學程 或雙主修者,得再次申請抵免科目學分。
- Article 2 Students who are eligible for course credit waivers include:
  - 1. Interdepartmental or inter-program transfer students
  - 2. Intercollegiate transfer students
  - 3. Those who are admitted by passing their second-year joint college entrance examination.
  - 4. Those who have received credits on any courses completed prior to matriculation.
  - 5. Those who have completed any courses offered for the fourth and fifth years of study by a five-year junior college program.
  - 6. Those who have completed any courses on a master's/doctoral program with a grade of at least 70 prior to matriculation.
  - 7. Those who have completed any courses on credit programs offered by NCKU for summer sessions and approved by the major department, graduate institute or program.

- 8. Those who are granted approval by NCKU to study abroad or are recommended by NCKU to study for a short term at an overseas university.
- 9. Students holding an associate degree or higher diploma from a Hong Kong institute of education.
- 10. Those who have received credits offered by the Ministry of Educationaccredited colleges or universities abroad and approved by the major department, graduate institute or program.

Those with student status defined in Items 1, 2 or 3 who are granted approval to transfer to another department (degree-program or class-category) or to pursue a minor (degree program) or double major shall re-apply for course credit waiver.

- 第三條 前條所列各類學生抵免學分數與轉(編)入年級規定如下:

  - (二)重考(含專科畢業生)新生,依法取得學籍時,其已修及格之科目學分,得 酌情辦理抵免及提高編級。 學士班抵免四十四十學分以上者得編入二年級,抵免學分以上者得編入二 年級,抵免八十八十學分以上者,得編入三學分以上者,得編入三年級, 抵免年級,抵免一百一十一百一十學分以上者,得編入四年級,但二專或 五專畢業生最高學分以上者,得編入四年級,但二專或五專畢業生最高編 入三年級,退學學生最高編入退學之年級。編入三年級,退學學生最高編 入退學之年級。提高編級限入學當學期辦理提高編級限入學當學期辦理。
  - (三)以香港副學士以香港副學士((或高級文憑或高級文憑))資格入學為本校學 士班者,申請學分抵免並經各資格入學為本校學士班者,申請學分抵免並 經各學系學系((學程學程))核准後,至多得以提高編級修讀三年級。核准 後,至多得以提高編級修讀三年級。 研究生抵免學分總數由各學系(所、學程)自訂,抵免後學士、碩士班學 生至少修業一年、博士班學生至少應修業滿二年以上,且在學期間內至少 修習一門有學分數之科目。 推廣教育學分班抵免規定畢業學分(不含論文指導學分)總數,以不超過 二分之一為原則,各學系(所、學程)另有更嚴格規定,從其規定。
  - (四)轉學生比照前一、二款規定辦理;若有特殊情形得比照有關規定辦理。 前項各款學生除五專畢業生外,辦理申請抵免科目學分,如已計入取得畢 業學分規定之課程及學分數者,不得申請抵免。如有其他特殊情形,經系 所專案簽請教務長核准者,方可抵免。

- Article 3 The rules governing the academic level classification of students based on the results of course credit waiver are as follows:
  - (1) Freshman-turned-sophomore interdepartmental (inter-program, inter-category) transfer students are allowed in principle to have course credits waived up to the total number of credits designated for the freshman class of the new department (program, class-category).

Sophomore-turned-junior interdepartmental (inter-program, inter-category) transfer students are allowed in principle to have course credits waived up to the total number of credits designated for the freshman and sophomore classes of the new department (program, category). Following course credit waiver, a sophomore-turned-junior transfer student is required to complete the minimum number of credits for graduation as designated by the new department within the maximum four-year duration of study (excluding extended years). Those who will fail to do so shall be classified into the sophomore class level of the department.

Those classified into a lower class level are allowed to have course credits waived up to the total number of credits for the first two or three years of study in the department.

(2) Newly accepted undergraduate students who passed their second-year joint university entrance examination or who graduated from junior colleges are entitled to apply for course credit waiver or/and be classified into an upper class level of their major department.

In general principle, those who have waived 40 or more of the minimum number of course credits required for graduation shall be classified into a second-year class level; those who have waived 80 or more course credits shall be classified into a third-year class, and those who have waived 110 or more course credits shall be classified into a fourth-year class. However, graduates from two- or five-year junior colleges are only allowed to be classified up to a third-year class, regardless of the number of course credits waived. A newly accepted dropout student is only allowed to be classified up to the original class level at which the dropout occurred. The classification into an upper class shall be completed upon enrollment in the first semester of the first academic year.

(3) Undergraduate program students holding an associate degree (or higher diploma) from a Hong Kong institute of education, upon approval of an application for a course credits waiver, are only allowed to be classified up to a third-year class of their major program.

The total number of credits allowed for graduate program course waiver shall be designated by each individual department or graduate institute.

Basically, following the completion of their course credit waiver, undergraduate students and master's program students are required to study for a minimum

duration of one year, while doctoral students are required to study for a minimum of two years, with at least one course taken for each semester.

(4) In general, applications for course credit waiver by intercollegiate transfer students shall be processed according to the same rules specified in Items (1) and (2). Any special applications shall be dealt with according to the relevant regulations.

All eligible students as defined in this article, except five-year junior college graduates, are not allowed to apply for waivers of course credits that have been counted into their graduation credits. Any special applications for course credit waiver shall be reported by the related department/institute and approved by the Vice President for Academic Affairs before they are administered.

- Article 4 The scope of course credit waiver is defined as follows:
  - Required course credits (including general courses and general education courses)
  - (2) Elective course credits (including related courses)
  - (3) Minor program course credits (including credit waiver for major program change as a result of interdepartmental or intercollegiate transfer)
  - (4) Double-major program course credits
  - (5) Educational program course credits
- 第五條 抵免學分之原則規定如下:

  - (三)科目名稱、內容不同而性質相同者。
- Article 5 The types of courses applicable to credit waiver are prescribed as follows:
  - (1) A course is the same as an established program course in terms of its title and contents.
  - (2) A course is the same as an established program course in terms of its contents, regardless of its title.
  - (3) A course is the same as an established program course in terms of its nature, regardless of its title or contents.
- 第六條 不同學分互抵後之處理,規定如下:(一)以多抵少:抵免後以少學分登記。

(二) 以少抵多:所缺學分應予補修,如無法補足學分數者,不得抵免。

- Article 6 An application of course credit waiver for a course with divergent credit hours is regulated as follows:
  - (1) Where the number of credit hours earned for a completed course exceeds that of the course being waived, the smaller number shall prevail in the calculation of credits waived.
  - (2) Where the number of credit hours earned for a completed course is smaller than that of the course being waived, the smaller credit-hour number may be granted and registered as a partial waiver, which requires the applicant to make up the discrepancy. Should the applicant fail to do so, the waiver will be annulled.
- 第七條 申請抵免學分之期限及程序:

    - (二)申請程序:請於申請期限內至教務處註冊組網頁下載抵免學分承認表,再 至各學系(所、學位學程)辦理並應繳驗(交)原校修讀之成績單及修業(或轉 學)證明書,必要時可採取甄試方式認定其程度及決定是否可以抵免。 須甄試及格始可抵免之科目,應依第一款規定時間辦理完峻。
- Article 7 Deadlines and procedures for course credit waiver application:
   Applications for course credit waiver by transfer students or newly accepted students shall be completed upon enrollment in the first semester of the first academic year. The deadlines and procedures for course credit waiver application are detailed as follows:
  - (1) Application deadlines: Newly-admitted students (including intercollegiate transfer students) or interdepartmental transfer students (including inter-program or inter-category transfer students) are required to complete their applications for course credit waivers within the first week from the opening day of school (according to the university calendar) in their first academic year. However, those defined in Items (7) and (8) of Article 2 who have completed a period of overseas study for one semester, or a short term with academic transcripts or certificates, shall complete their course credit waivers within the first week from the opening day of school in the following semester immediately after their return.

Any special applications for course credit waiver that have been reported and approved will be processed on a case-by-case basis.

(2) Application procedures: Applicants are required to complete an application form

for course credit waiver downloaded from the webpage of the Division of Registrar under the Office of Academic Affairs, and submit the completed form along with the related transcripts or academic certificates to the department office for review. If necessary, a test may be conducted to decide a course credit waiver. Applicants passing a test for a course credit waiver shall complete their applications by the designated deadline, as specified in Item (1) under this article.

- Article 8 Regardless of the number of course credits waived, every applicant is required to enroll in courses with a minimum number of credits required for each individual semester.
- 第九條 抵免學分之審核,通識教育科目由通識教育中心負責審查,各系(所、學位學程)專業科目,應由各該系(所、學位學程)分別成立審查小組負責審查,體育科目,應由體育室分別負責審核,並由教務處複核。轉系生、轉學生原在本校已修習之共同核心課程、專業課程及體育等科目成績及格者,由各學系審核之。
- Article 9 Applications for course credit waivers shall be reviewed by departments or academic units offering related courses and approved by the Office of Academic Affairs. A waiver application for general education courses shall be reviewed by the General Education Center, a waiver application for program courses shall be reviewed by each individual department/graduate institute, and a waiver application for physical education shall be reviewed by the Physical Education Office. Applications by interdepartmental or intercollegiate students for credit waivers of general courses, program courses or physical education courses completed previously at NCKU shall be reviewed by each individual department/graduate institute.
- 第十條 抵免學分之登記,應依下列規定辦理:

  - (三)重考或先修讀學分後考取修讀學位新生,應將抵免科目學分,登記於編入 年級前歷年成績表內各學年成績欄。
- Article 10 The registration of course credit waivers shall be administered as follows:
  - For interdepartmental transfer students, courses completed at the original department (degree-program, class-category) that are waived shall be marked "TR" (for transfer credits) on the transcript.
  - (2) For intercollegiate transfer students, course credits waived (grades unmarked)

shall be registered in the grade columns designated for the preceding academic years on the transcript. e.g., for an intercollegiate transfer student enrolled as a sophomore, course credits waived shall be registered in the grade column for the first academic year and for that enrolled as a junior, courses waived shall be registered in the grade columns for the first two academic years.

- (3) For those defined in Items (3) and (4) of Article 2, courses waived shall be registered in the grade columns for the past academic years prior to class classification.

- Article 11 Applications of course credit waivers for courses completed at overseas universities accredited by the Ministry of Education shall be processed equivalently according to the relevant preceding regulations. Basically, any credit transfer or waiver shall take into account the number of course hours and course contents. The principles of credit calculation for courses completed at overseas universities are as follows:
  - (1) Half of the number of credits for a course completed at any university adopting the European Credit Transfer and Accumulation System (ECTS, excluding universities in the UK) shall be calculated and rounded up to nearest whole digit for credit transfer or waiver.
  - (2) One-fourth of the number of credits for a course completed at any university adopting the Credit Accumulation Transfer Scheme (CATS) shall be calculated and rounded up to nearest whole digit for credit transfer or waiver.
  - (3) The number of credits for a course completed at any university adopting the credit transfer and accumulation system used in the USA, Japan or mainland China shall be calculated for credit transfer or waiver.

Article 12 Any matters that are not regulated shall be administered according to NCKU

Academic Regulations and relevant rules.

- Article 13 These regulations should be approved by the Academic Affairs Council and ratified by the Ministry of Education to take effect, as should any amendments to them.

A course coordinator should hold a position as an Assistant professor (or above) and also possess a PhD (or equivalent, e.g. D.Phil., D.Sc.) degree.

Potential advisor should meet the following requirements:

- I. Hold a position as an Assistant Professor or above (e.g. Associate Professor, Professor, Distinguished Professor, Chair Professor)
- II. Have previous experience in: 1) supervising post-graduate students; or 2) acting as a committee for master or doctoral student's qualification exam for oral defense examination for dissertation.
- III. A principal investigator who has been awarded a grant/s to carry out his/her research; or has published paper/s in SCI/SSCI-indexed journals in the past three years.
- IV. A faculty member, or adjunct faculty member, of the Institute of Allied Health Sciences with a minimum of one year's experience.
- P.S. An advisor should be a full-time faculty member of one of the following departments/institutes: Institute of Behavioral Science, Department of Nursing, Department of Psychology, Department of Occupational Therapy, Department of Physical Therapy, and Institute of Gerontology.
- P.S. An advisor's appointment needs to be approved during the institute staff meeting if an advisor candidate has less than one year's academic experience in the Institute of Allied Health Sciences.

Each PhD student must choose, based on the advisor's expertise, their own thesis advisor that matches the student's research interests and goals. After discussing with a particular faculty member, and the faculty member agreeing to be the student's thesis advisor, each student must turn in the PhD Advisor confirmation form to the Allied Health Sciences department office before the second semester of the entering academic year.

Each thesis advisor must be a faculty member from the Institute of Allied Health Sciences. If necessary, a student can have a thesis co-advisor. As for the research level, the advisor should have 4 of the following qualifications:

- I. Associate professor or higher.
- II. Advised other graduate students or participated in other oral examinations for dissertations.
- III. Has conducted a research project or published a research paper in the past three years.
- IV. Been on faculty, or are an adjunct faculty member, in the Institute of Allied Health Sciences for more than one consecutive year. If the faculty member has not completed one year of service yet, the application can still be submitted as a case for discussion in the department affairs committee.
- P.S. An advisor should be a full-time faculty member of one of the following departments/institutes: Institute of Behavioral Science, Department of Nursing, Department of Psychology, Department of Occupational Therapy, Department of Physical Therapy, and Institute of Gerontology.

第二條 研究生指導教授應依據本校研究生章程第七條規定,指導教授須為本校教師,其資 格及選任應依本所規定並經所長同意。 The advisor of the graduate student should adhere to Article 7 in the NCKU Graduate Student Policies and Rules. The advisor shall be assigned from NCKU faculty members. The qualifications and appointments of academic advisors shall be regulated by the graduate institute and approved by the director.

第三條研究生於就讀期間,如研究生或原論文指導教授因故無法維持指導關係,有更換指導教授之必要,得由研究生或原論文指導教授向所長提出更換論文指導教授之要求,更換指導教授時,需填寫「博士論文指導教授確認異動書」,經學生、原指導教授與新指導教授同意簽名後,送所長簽名後生效。完成博士班論文指導教授之確認,確認後至所務會議核備。 但有下列情形之一者,得由本所所長召開所推會議議決,由適當教授或所長擔任指導教授,或採其他妥適之方式處理:

- (一)原指導教授拒絕同意者。

- (三) 其他顯足以影響師生良好關係者。

When the student and advisor could not maintain an adequate relationship, either the student or the advisor could raise the issue to stop this relationship by requesting the director. When such a request is made, the form "Applications for Change of PhD Advisor(s)" shall be completed and signed by the student, original advisor, and new advisor. The effect of the change of advisor is taken after the AHS director signs the form. After confirming the PhD advisor, it shall be ratified by the Institute Affairs Council. However, the AHS director shall call the Institute Affairs Promotion Council to decide on an appropriate professor (or the director) to be the advisor, or to take other appropriate treatment when one of the following conditions happens:

(1) The original advisor refuses to agree on the change;

(2) The graduate student cannot secure a new advisor;

(3) Other aspects that could obviously impact the relationship between teachers and students.

Degree examination results: a grade of 100 is a perfect mark and a grade of 70 is the minimum passing grade with the stipulation that at least two-thirds of the committee members must award a passing grade.

Grading: score of 90 and above--- Outstanding, 86-89--- Excellent, 80-85 --- Good, 76-79--- average, 70-75 --- minimal pass, less than 70 --- fail.

After a PhD student passes the qualification exam and completes the coursework and

dissertation requirements as mandated by the Ministry of Education and whose dissertations meet the following requirements, may be recommended to apply for their final thesis defense exam. The student's doctoral thesis should be written within the deadline (set by their advisory committee) and approved by their dissertation advisory committee.

- (1) All graduate courses have been completed.
- (2) At least two papers (presented either orally or by poster) to international conferences (with summary(abstract)) must have been submitted/accepted to be qualified for the oral defense of the student's thesis.
- (3) During the study period in the AHS, the student shall have at least one original or systematic literature review published (or accepted for publication) in an SCI, SSCI, or EI international journal as the first author. Additionally, students must submit another paper to an SCI, SSCI, or EI international journal (with proof of submission). The published (or accepted) and submitted papers shall be the original papers generated during the PhD study period, with the advisor or co-advisor (with the advisor's consent) as the corresponding author. The student shall complete the "Review Form of International Publication for Dissertation Final Defense" signed by the advisor.
- (4) Results of the plagiarism for the dissertation via Turnitin should be approved by his/her advisor.
- (5) The student's application has been approved by their advisor.
