### 簡介 Introduction

#### 1. 源起 HISTORY

This doctoral program is open to all health care professionals. We help our students develop innovative knowledge in health science, emphasizing scientific and philosophical viewpoints, interdisciplinary training, and a global vision. It is our mission to cultivate high-quality researchers and professionals with holistic approaches, that focus on biological, psychological, social and spiritual needs of patients, as well as the development of health care research and policies that address these needs.

Established in 2002, the institute integrated a cluster of health care professions and educational programs, that included the disciplines of Clinical Psychology, Nursing, Physical Therapy, and Occupational Therapy. Doctoral students have been enrolled in this program since August, 2003. The current number of enrolled students is 73. Students may choose one of the four tracks mentioned above.

#### 2. 宗旨 MISSION STATEMENT OF THE INSTITUTE

Cultivate leaders in healthcare professionals.

Develop advanced, multi-disciplinary knowledge for holistic healthcare.

Promote development of healthcare professionals.

Elevate physical and mental health of human beings as well as the quality of life.

### **3. 發展重點與特色 SPECIFIC HEALTHCARE FOCUS OF THE PROGRAM**

#### **(1) Physical and Mental Healthcare for Women**

In order to promote the physical and psycho-social health of women, the institute focuses on the following areas: i) the investigation of life-cycle related physical and mental health issues such as premenstrual syndrome, pregnancy stress, pre- & post-natal depression, aging, and menopause from genetics, physiological, psychological, social, and cultural aspects, ii) for women's mental health, we focus on some special topics, such as breast cancer, depression and domestic violence, and iii) the education of students to be high-level research and healthcare professionals in this area.

#### **(2) Geriatric Cares**

Based on the knowledge that chronic disease development is significantly related to life style, the institute places emphasis on the following topics: i) the acquisition and transformation of various health-related behaviors in geriatric subjects and their relevant factors, and ii) the development of effective healthcare strategies and programs for geriatric patients. Our ultimate goal is to become the top research center in Asia-Pacific region.

#### **(3) Healthcare for Mental or Physical Development**

Ongoing work is establishing a comprehensive inter-disciplinary healthcare model for mental and physical development, including theory, evaluation, and intervention. With this as our guide, the environmental and culture impacts on mental and physical development are investigated and high-level research and healthcare professionals in this area are trained.

Another line of research is placed on the development of motor functions, perception, intelligence, social emotion, and musculoskeletal growth of toddlers. The goal is to design early interventions to help those children who suffer from abnormal development conditions.

#### **(4) Applied Movement Sciences for Cognitive-Motor Disabilities and Sports /Occupational Injuries**

This research group applies movement sciences to investigate various aspects of interaction and integration of motor and cognitive functions in normal subjects and patients with cognitive/motor dysfunction and the pathomechanics, diagnosis, and intervention of sports/occupational injuries. Our research efforts are directed towards i) the acquisition of advanced knowledge of cognitive-motor function and the development of therapeutic strategies in patients with cognitive motor disabilities; ii) the study of the association between cognitive and motor performances in patients with central nervous system (CNS) injuries; and iii) the investigation of etiologies, diagnoses, treatments, and prevention measures for sports/occupational injuries via basic and clinical research. Our ultimate goal is to foster students to be top researchers and leaders of the healthcare profession.

## (5) Mental Healthcare

Studying the issues of multi-disciplinary healthcare and disease prevention (primary, secondary & tertiary prevention), based on both international and domestic trends, so these research findings can be applied in the clinical setting to improve the well-being of people. The students are trained to be high-level researchers and healthcare professionals in this area.

## 4. 課程規劃 COURSE PLANNING

Due to the incoming time of multi-disciplinary healthcare and lacks of professionals, especially in the following four fields, clinical psychology, nursing, physical therapy and occupational therapy, this institute was then set up. We do not only aim to train clinical care professional, but also cultivate academic experts in several aspects.

Three training values are as follows:

- 1) To develop holistic care capacity in clinical field
- 2) To improve research and academic ability
- 3) To broaden global vision in both clinical and academic

(1) The “Seminars” are designed to be a student-centered learning process by providing an opportunity for the student(s) to engage in an in-depth discussion of his/her research interests with his/her mentor(s) and members of his/her dissertation committee.

(2) In “Clinical Research Design”, students from different research group will be expected to write a multi-disciplinary research proposal.

(3) The core concept of the thesis shall be multi-disciplinary. The advisor for the thesis shall be an expertise from the multi-disciplinary research based. The department suggests students to have one co-advisor who is from the multi-disciplinary research.

Clinical Psychology A group : Advanced Psychopathology(3 credits), Advanced Psychological Assessment (3 credits), Psychotherapy(3 credits)(Take at least 1 of the previous 3 courses )and Supervision of Clinical Psychology Practice(2 credits).

Nursing Group : Philosophy and Knowledge Construction in Nursing(3 credits), Ethical consideration and practice in Health Care(3 credits).

### 課程相關規定 Course Regulations

#### 1.各組碩士班直升博士班規定(Masters students go straight for doctoral program requirements) :

- (1)臨床心理組由碩士班直升博士班同學，須補滿心理病理學相關學分 9 學分、心理衡鑑相關學分 6 學分、心理治療相關學分 6 學分以及臨床心理學實習(I)(II) 16 學分，合計 37 學分；但已具有行政院衛生署臨床心理師證書者，得免臨床心理學實習(I)(II)16 學分，合計 21 學分。
- (2)護理組由碩士班直升博士班同學，須補滿護理倫理、護理理論、護理研究、生物統計學、各科高級護理學(I)(II)、各科高級護理學實習(I)(II)等必修學分計 23 學分，及選修 2 學分護理文獻評論，合計 25 學分。
- (3)職能治療組由碩士班直升博士班同學，須補滿職能治療學系碩士班所規定之必修、選修課程合計 24 學分。
- (4)物理治療組由碩士班直升博士班同學，另須補滿物理治療臨床決策分析、生物統計、物理治療專題討論(一)(二)、物理治療研究方法學等必修學分計 11 選分，從肌肉骨骼系統疾病鑑別診斷學、姿勢與步態分析、小兒物理治療專題、動作障礙與肌電生理、神經疾病與動作控制異常、神經物理治療專題研究、高等操作治療學暨實習、動作發展與動作分析等至少選修 13 學分，合計 24 學分。

2.本所發展重點與特色為以下五項研究群：(1)婦女健康、(2)高齡健康與照護、(3)身心發展與照護、(4)動作科學與照護、(5)心理健康，此五項研究群亦為本所跨領域之研究方向。本所入學考試採專業分組(臨心 A 組或 B 組、護理組、物治組、職治組)方式進行審查，為落實跨領域研究，學生入學後，需自選考之專業分組內之教師中選定指導教授，並於五項跨領域研究中選定至少一項研究群參加，且指導教授必需有參與該項跨領域研究群，此外，學生需依其選定之該項跨領域研究群之規定，修習相關課程。

2. **Five Specific program of Healthcare:**(1) Physical and Mental Healthcare for women (2) Geriatric Care (3) Healthcare for Mental or Physical Development (4) Applied Movement Sciences for Cognitive Motor Disabilities and Sports/ Occupational Injuries (5) Mental Healthcare. These five programs provide the framework for how the program's interdisciplinary research courses are organized. Within any of the courses offered by the program, the students will be grouped based on their specialty (Clinical Psychology, Nursing, Physical Therapy, and Occupational Therapy) to allow the assessment material to be evaluated separately. Students need to choose their advisor from each professional group and choose to study at least one after admission. The advisor also needs to study

and participate in the chosen healthcare focus. Students need to fulfill the course requirements of each interdisciplinary research course.

### 3.先修課程規定：

- (1)健康照護的倫理探討與實踐需預先修習護理學系碩士班之生命倫理學之課程，或通過 challenge test。已申請通過免修的同學，仍選修此課程，不得列入本所畢業學分數。【97 學年度第二次所務會議】
- (2)各課課程之修課規定（如需經過 Challenge Test 或先修課程等），則依當年度開課教師之修課要求辦理【93 學年度第五次所務會議】

### 3. Pre-requisites:

- (1) Before taking *Ethical consideration and practice in Health Care*, students must have first successfully completed the course *Live Ethics* in the Nursing Department for Masters Program or passed the specific challenge test. Any students who are approved to not taking course but still taking it as optional course, the credit isn't account for graduated requirements.
- (2) Each course may have its own specific eligibility requirements for participating in it (for instance, the requirement of passing a particular challenge test or successfully completing specific prerequisite courses) which are determined by each course co-coordinator.

Integrated Health Sciences Seminar (I): Students who has not chosen an advisor may take the course, but the course committee chair will assign a specific faculty member for the supervision when these students are presenting.

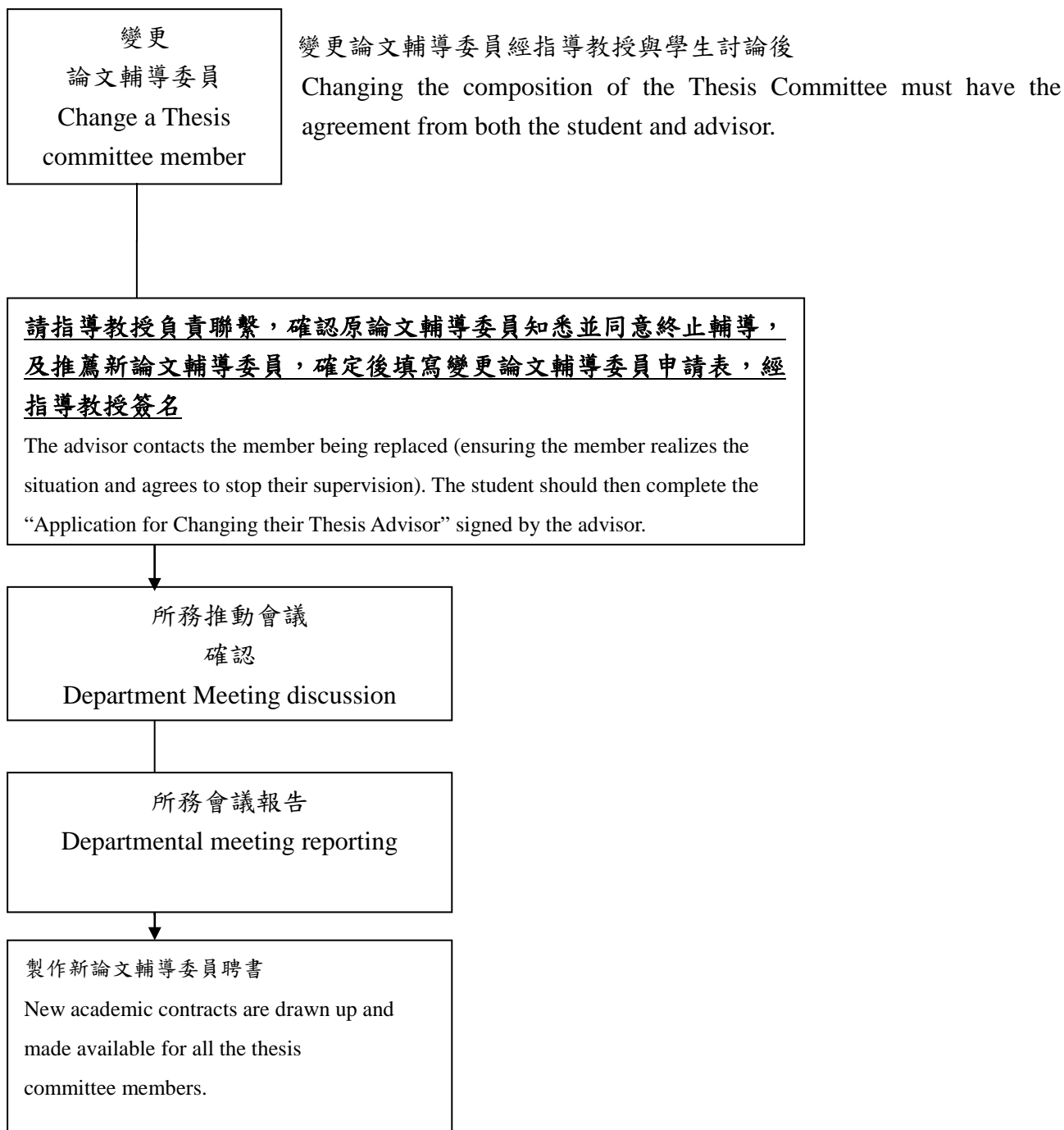

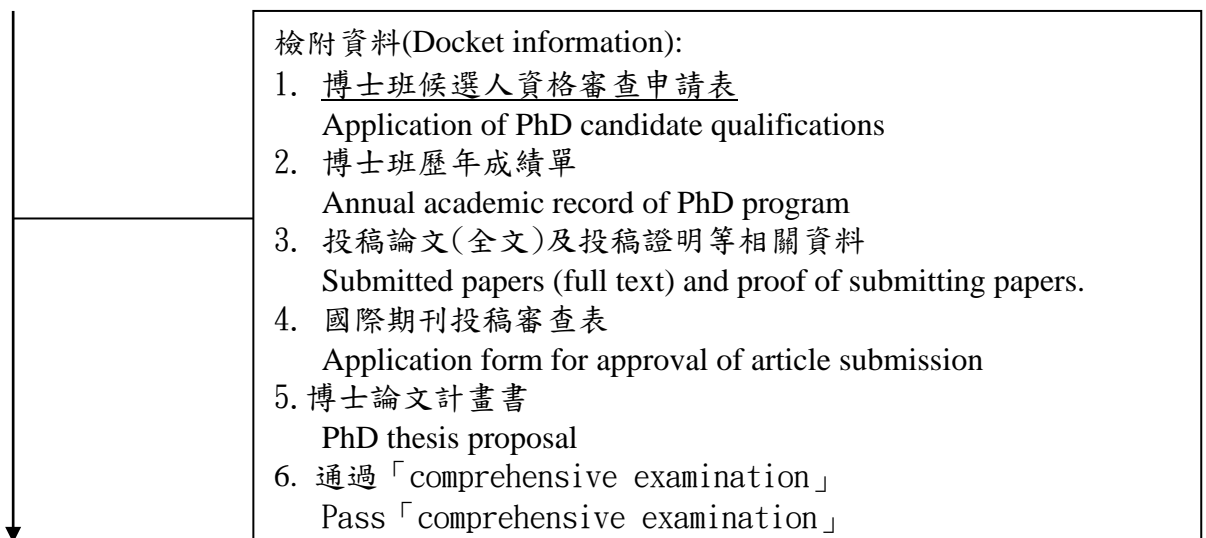

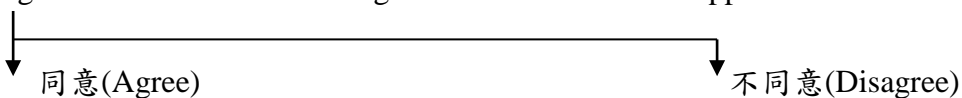

1. 指導教授邀請博士候選人資格考試審查委員，至少要有三至九名委員出席（論文輔導委員為當然委員），方得舉行口試。

The oral defense exam may commence as the advisor invites at least 3~9 committee members to physically attend the exam from the Dr. Candidate Qualification Exam Board. (The dissertation supervisors are oral exam committee members)

2. 口試舉行前，首先推舉口試委員召集人，由召集人主持口試會議，召集人不得為指導教授。On the day of the exam, a Chairperson is elected from among the committee members. The candidate's adviser cannot assume the role of Chairperson. The Chairperson's responsibility is to chair the oral examination meeting.

3. 考生與聽眾離開考場，由召集人主持，並由指導教授介紹考生，就其修業內容與投稿文章是否已達所上規定，方得進行口試。須有三分之二(含)以上委員同意，才算通過。

The first order of business for the Chairperson is to instruct the candidate and audience to leave the examination room. The candidate's adviser will then summarize the work performed by the student. The members discuss if the contents of the candidate's draft of their dissertation along with any other study activities brought to the attention of the committee by the candidate's adviser merits an oral defense. A minimum two-thirds of committee members must agree, as determined by vote, that the candidate's efforts merit immediately proceeding with the oral defense exam.

The final grade is calculated as the average of each Committee member's grade; this is recorded on the school record sheet. This final grade is **NOT** subject to appeal.

To avoid unfairness, the scoring must conform to the following standards. Departmental Grading Criteria:

Degree examination results: a grade of 100 is a perfect mark and a grade of 70 is the minimum passing grade with the stipulation that at least two-thirds of the committee members must award a passing grade.

Grading: score of 90 or more --- Outstanding, 86-89--- excellent, 80-85 --- good, 76-79--- average, 70-75 --- minimal pass, less than 70 --- fail.

- 一、健康照護科學研究所（以下簡稱本所），依據本所博士學位考試實施辦法第三條第三項第二點規定，鼓勵學生出國研修，拓展學生視野，促進國際學術及文化交流，加強國際觀，特訂定本要點。The Institute of Allied Health Sciences Ph.D. Program ( hereinafter referred to as we), according to our Ph.D. examination policy Article 3, third item, second point, we encourage students to go abroad to broaden their horizons with the following objectives: promote international academic and cultural exchanges and strengthen the student's international global competency.

The committee should have met 1-2 times to evaluate the student's class performance、qualification exam topics and subjects, research progress and discuss the graduate's study content,. 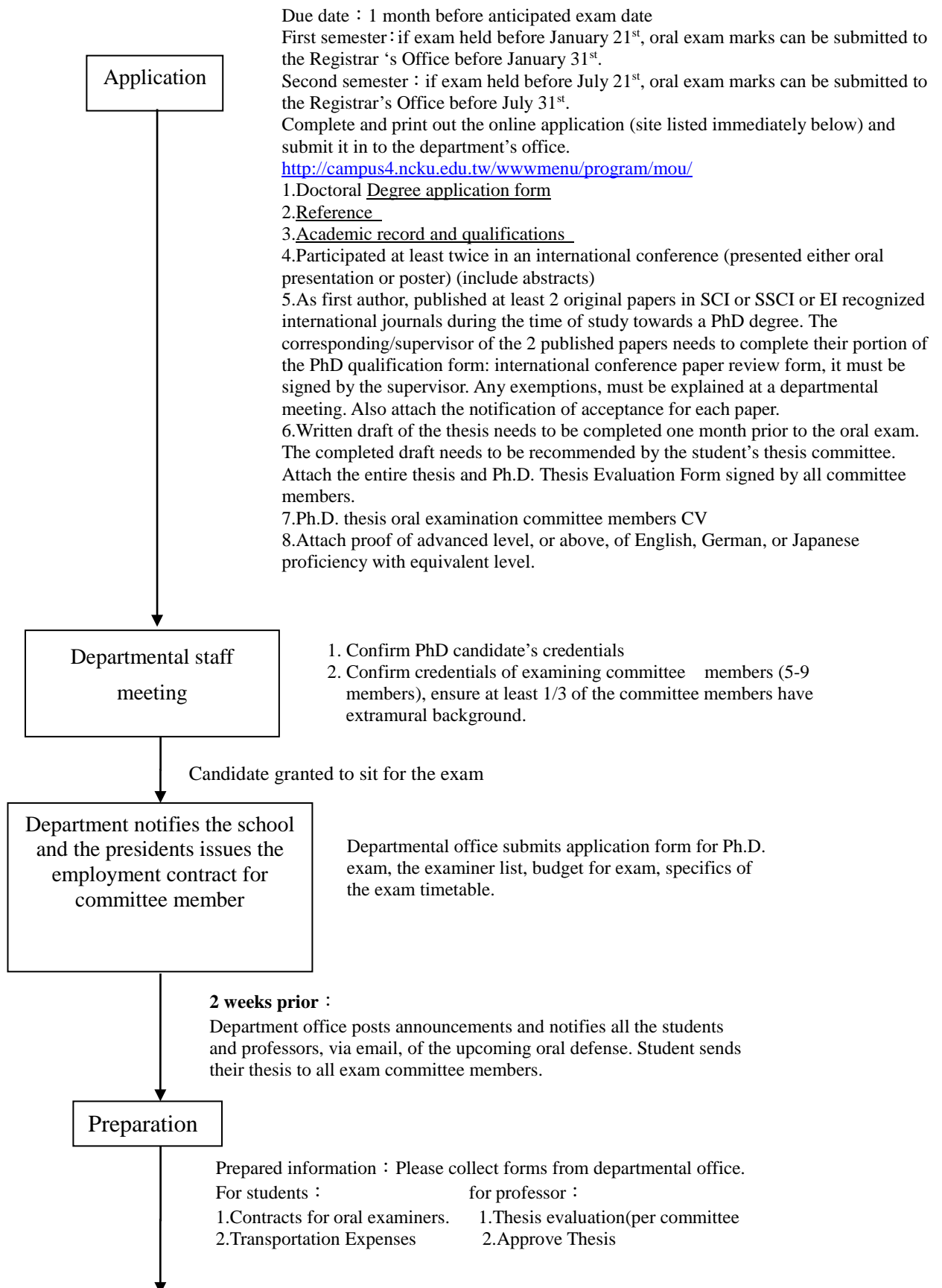

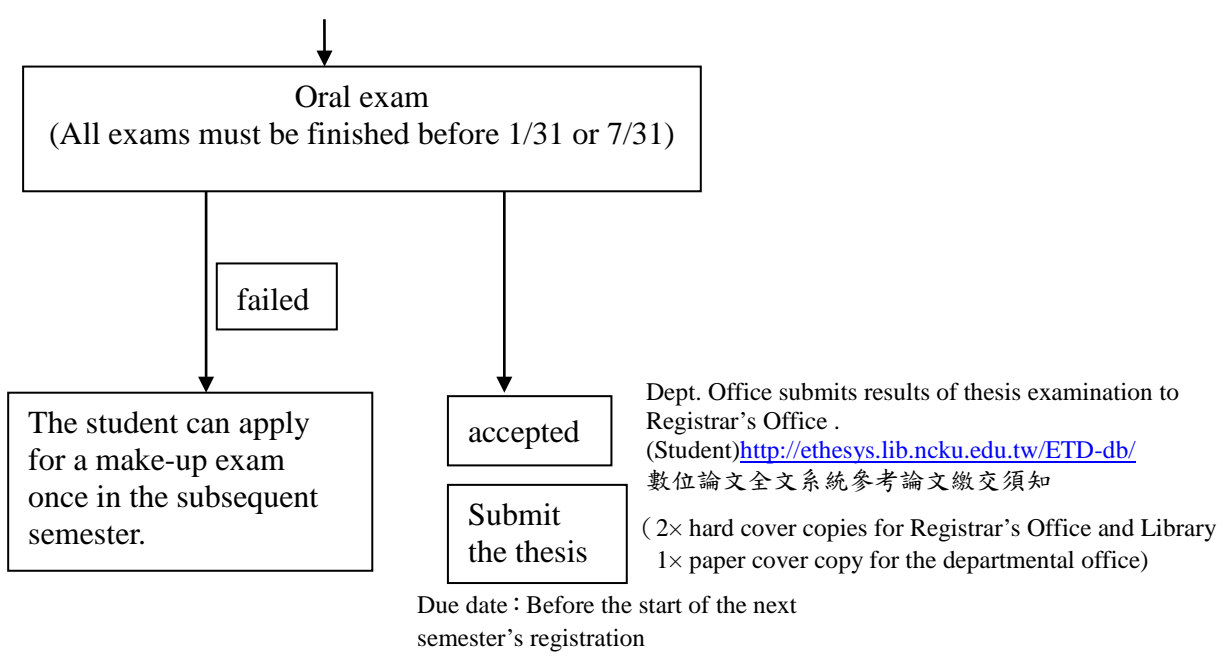

## National Cheng Kung University Institute of Allied Health Sciences Ph.D. Program Oral Defense Procedures

1. 博士學位考試委員會置委員五至九人，其中校外委員須三分之一（含）以上(論文輔導委員為當然委員)，方得舉行口試。

The candidate's Ph.D. exam committee is composed of five to nine members, and this includes dissertation supervisors. 1/3 of the committee members must be external examiners. Once all committee members have been approved, then the oral defense procedures may commence.

2. 口試舉行時，首先推舉口試委員召集人，由召集人主持口試會議，召集人不得為指導教授。

On the day of the exam, a Chairperson is elected from among the committee members. The candidate's adviser cannot assume the role of Chairperson. The Chairperson's responsibility is to chair the oral examination meeting.

3. 考生與聽眾離開考場，由召集人主持，指導教授介紹考生，就其修業內容與論文內容是否已達可以口試程度進行討論。須有三分之二(含)以上委員同意，才算通過。

The first order of business for the Chairperson is to instruct the candidate and audience to leave the examination room. The candidate's adviser will then summarize the work performed by the student. The members discuss if the contents of the candidate's draft of their dissertation along with any other study activities brought to the attention of the committee by the candidate's adviser merits an oral defense. A minimum two-thirds of committee members must agree, as determined by vote, that the candidate's efforts merit immediately proceeding with the oral defense exam.

If the threshold of two-thirds of committee members agreeing to continue with the oral exam is met, then the candidate and audience are permitted to re-enter the examination room.

5. 由考生進行20~30分鐘之論文報告。

The candidate is allowed 20 to 30 minutes to present a summary of their research studies.

6. 由口試委員們進行口試與答問。

The Committee members ask the candidate questions in turn.

7. 口試完畢；考生與聽眾出場；由召集人主持，對考生之表現與論文內容進行討論與評分，並由召集人統整意見給予總評，且紀錄於校方評分表上。

The candidate and audience are instructed to leave the examination room upon the completion of the questioning period to allow for deliberations among the Committee members. The



Chairperson collects comments and a grade from each examiner. The final grade is calculated as the average of each Committee member's grade; this is recorded on the school record sheet.

This final grade is **NOT** subject to appeal.

- 一、本所獎、助學金審查辦法依據本校研究生獎、助學金辦法訂定之。

Regulations for the scholarships or fellowships of(from) the graduate school are the same as those of the University.

- 二、本所獎、助學金金額及名額，由本所獎助學金委員會依據校方分配至本所之獎助學金總額及符合申請資格之名額決定。

The number of recipients for scholarships or fellowships are determined by the funding given the department by the University.

- 三、本所獎助學金審查委員會由所長召集二位教師共同組成。

The scholarship and fellowship committee is (composed of) the departmental director and two (department faculty members).

- 四、獎、助學金申請及審查：Application and Review for scholarships or fellowships:

(一) 申請人資格：Qualifications:

1. 於本所註冊在學（含復學生）之一、二、三學年一般生為限

Only those students who have been enrolled in this graduate program for less than 4 years are eligible. This includes returning school student who had previously suspended their studies.

2. 研究生有下列情形之一者不得申請本獎助學金：

A student who meets any of the circumstances listed below is ineligible for a scholarship or fellowship.

- (1) 在校外兼職兼薪者 Has a part-time job outside the school

- (2) 在校內兼職兼薪，或領有其他獎學金，其金額高於本獎、助學金者。Has a part-time job within the school, or will also receive financial support from another scholarship which is of higher monetary value than this scholarship.

3. 研究生參與主修有關之專題研究，其所領研究補助費金額未高於本獎、助學金者，得申請本獎、助學金。但同一時間內以領有一項研究補助為限。Students

are allowed to participate in research work/projects within their major field of study and still be eligible for the scholarship or fellowship, providing the allowance a student receives for this research work is less than the monetary value of this specific scholarship. To remain eligible students are permitted to participate in only one research project at a time.

4. 違反上述規定，一經查獲，將立即停發其獎、助學金，並追回已領之獎、助學金。If a student is found to have violated the eligibility conditions of the scholarships or fellowships, the scholarship or fellowship funding will be immediately suspended, and the student must return to the University any portion of the funding they have already received.

(三) 獎、助學金金額(The amount of funding)：

This depends on the number of students and the funds made available to the department by the University.

(四) 審查方法：(review)

由獎助學金審查委員會受理審查及公佈結果。

五、獎、助學金受領人責任義務(the obligation of the recipients)

凡支領獎、助學金之研究生均需參與所務行政及教學研究相關等業務，平均每週工作 10 小時，內容包括：

Every recipient of a scholarship or fellowship should participate in administrative tasks or research for an average of ten hours per week. These include:

- (一) 所務行政工作：包括文書處理、會議記錄、聯繫業務、網頁維護、檔案整理、文宣等相關事宜，由所長分派工作。Administration tasks: document processing、taking meeting minutes、contacting work, web page maintenance, document organizing editing、program promotion, and other specific work assigned by the director.

(二) 博士班核心及專業課程教學相關業務:

上述工作內容由所長依當學期所開課程之負責教師的需求分派。

PhD major lecture task (TA – Teaching Assistant): each semester, the director will assign TA responsibilities based on the teaching need.

The overall performance of recipients are decided by the director or a faculty member as each case dictates. This finding is reported to the scholarship/fellowship committee and if a students' performance is judged to be unacceptably poor, the student is ineligible for their scholarship or fellowship; funding is immediately suspended.

A recipient should inform the committee to stop providing Scholarship funding if any of the circumstances below arise:

(一) 學期中在校外兼職兼薪 Begin working a part-time job during the semester

(二) 休、退學 Suspend or quit your studies

Funding will be suspended as of the date each situation officially commences.

Students are not required to return any funding they received up until that date.
